Regular meeting of August 15, 2023.

CALL TO ORDER

Commissioner Jenkins called the regular meeting of the Board of Fire Commissioners of Benton County Fire District No. I to order at 4:00 p.m. at 1811A S. Ely St. Kennewick, Washington and via video-conference. In attendance at this meeting were Commissioner Carpenter, Commissioner Jenkins, Commissioner Phillips, Fire Chief/District Secretary Click, Deputy Chief LoParco, and Executive Director Paden-Lilly.

ADDITIONS TO THE AGENDA

There were no additions to the agenda.

CORRESPONDENCE

The correspondence received log and correspondence sent was reviewed.

APPROVAL OF MINUTES

A motion was made by Commissioner Carpenter to approve the regular minutes of August I, 2023, as presented. A second was provided by Commissioner Phillips, and the motion passed.

FINANCIAL REPORT

Fund Transaction Details

Fire Chief

Chief Click reported:

- The Corps of Engineers and he met yesterday to continue discussions on fire suppression reimbursements.
- He and Fire Marshal Tiplady visited Greenbriar Railcar Services in Finley. The facility is undergoing a major remodel and safety features are being upgraded.
- An after-action review was held last week regarding the Newell Road fire.

Deputy Chief

- He has transitioned to the new staff vehicle. The older truck has received new stickers and been cleaned up to be used as a duty officer vehicle.
- Station 170's medic unit will be at Brau n Northwest in Centralia for about a week to repair some bubbled paint.
