#### FINANCIAL REPORT

#### **Fund Transaction Details**

Presented to the Board were 2018 transactions #1346 through #1407. The transactions total \$138,078.44. General Fund \$100,696.13; electronic payroll transfers \$15,286.48; federal payroll tax payment \$6,557.43; Hazmat Fund \$6,009.38; Fire Training Center Operations Fund \$8,878.78; and SCBA Fund \$650.24. Commissioner Houchin made a motion to approve the vouchers. Commissioner Morris seconded the motion and the motion passed unanimously. #### **REPORTS**

Commissioners, chief and staff reported the following:

- Chief Click reported:
  - The Locust Grove fire on July 21, was declared State Mobilization. Captain Gutzmer was the Incident Commander.
  - With the heavy fire season, there has been many learning opportunities for our members. There is a tremendous shortage of mid-level overhead personnel in our area and throughout the State. More training is needed to increase depth of knowledge and experience.

- The bay door springs at Station 120 broke; parts have been ordered by Dondi's Garage Doors.
- o The bay door cable at Station 160 came off the roller and it was repaired.
- o The lighting project is complete, and a PUD rebate is expected.
- A couple staff vehicles have been scorched during fires; parts are on order and they will be repaired.
- o A starter was lost on E1126; it has been repaired.
- PIO Baker reported:
  - o Station I I 0 will take a Type I engine to the National Night Out event tonight.
  - o The Benton-Franklin Fair Parade will be on August 18.
  - Trios normally staff the first aid tent at the Fair each year. Due to an exorbitant cost assessed this year, the Fair Board reached out to Captain LoParco, who is working on staffing the tent with EMS volunteers.

# **ATV Purchase**

An All-Terrain Vehicle (ATV) has been budgeted to be purchased this year. The Equipment Committee and volunteers have researched which model would best meet the needs of the District and have recommended a Polaris Ace. A used 2016 Polaris Ace has been located for sale in Klamath Falls, Oregon in the amount of \$8,500. The vehicle has 203 miles on it and includes a roof, windshield, and extra lighting. After a discussion, Commissioner Houchin made a motion to purchase the used Polaris Ace ATV in the amount of \$8,500. Commissioner Sleater seconded the motion and the motion passed.

# Temporary B/C Upgrade

With the retirement of Battalion Chief Cole, Chief Click is recommending to upgrade Captain Gutzmer to that position until the testing process takes place. Commissioner Sleater made a motion to upgrade Captain Gutzmer to the position of Battalion Chief until the testing process is complete. Commissioner Houchin seconded the motion and the motion passed.

# **SeWAG Parts and Components Quotes**

Two quotes were requested for SeWAG Self-Contained Breathing (SCBA) system components for device maintenance. LN Curtis had the lowest quotation in the amount of \$16,278.92. Commissioner Sleater made a motion to award the purchase to LN Curtis. Commissioner Morris seconded the motion and all commissioners voted in favor of the motion.
